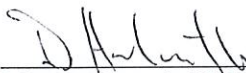
**A BYLAW OF THE TOWN OF ROSTHERN TO AMEND BYLAW NO. 2008-08,  
KNOWN AS THE ZONING BYLAW.**

The Council of the Town of Rosthern, in the Province of Saskatchewan, enacts to amend Bylaw 2008-08 as follows:

1. The "Zoning District Map" referred to in Section 7 and forming part of Bylaw No. 2008-08 is amended as follows:
  - 1.1) By rezoning from C2-Highway Commercial District to CS-Community Service District the property legally described as part of Lot 7, Block 3, Plan 101905488; Lot 1, Block B, Plan AC3292; Lot 1, Block 3, Plan 83PA21199 and shown on a plan of proposed subdivision dated April 2, 2012 and signed by R.J. Morrison, SLS.
2. This bylaw shall come into force and take effect on the date of final passing thereof.

Introduced and read a FIRST time this 8<sup>th</sup> day of January, 2013.  
Read a SECOND time this 22<sup>nd</sup> day of January, 2013.  
Read a THIRD time and passed this 22<sup>nd</sup> day of January, 2013.

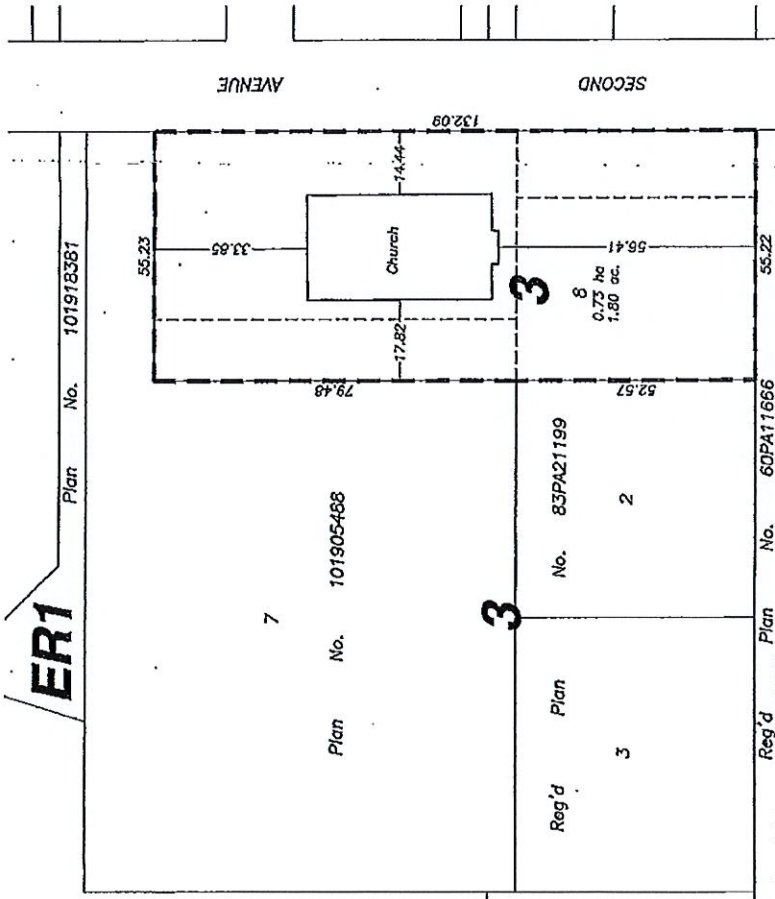
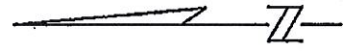
