



Bylaw 2016-04

A BYLAW OF THE TOWN OF ROSTHERN TO PROVIDE FOR THE FIXING OF WATER RATES, SEWER SERVICE CHARGES AND UTILITY INFRASTRUCTURE FEES

The Council of the Town of Rosthern, in the Province of Saskatchewan, enacts as follows:

- 1) The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached.
- 2) Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
- 3) Every customer shall pay a water and sewer infrastructure fee on each property, as set out in Schedule "C".
- 4) Accounts for water service and/or sewer service and/or infrastructure fee shall cover a period of one month, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$50 to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be \$100.
- 5) A penalty of 2% will be added to all water and sewer accounts outstanding at the date of the next billing.
- 6) Bylaw No. 2013-09 is repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on October 1, 2016 and approval being issued by the Local Government Committee.

Read a SECOND time this 11th day of July, 2016.

Read a THIRD time and adopted this 11th day of July, 2016.
